Green chillies of Uttar Pradesh hot sellers worldwide

Lucknow,

They are 'hot' by all standards and they are much in demand. Green chillies from Uttar Pradesh are reportedly flying off the shelves in European supermarkets.

It's not just the succulent mangoes of the state, its green chillies too are now wowing people abroad and exporters here are smiling all the way to the bank. Time was when green chillies from Uttar Pradesh were sent on a "trial basis" to some European and Arab nations. But now exporters are receiving orders from other regions too. With orders for the chillies pouring in thick and fast, exporters are busy packaging consignments for markets in Germany, the Netherlands, Italy and England. "We buy the chillies straight from the farmers and then clean, grade and package them for export," Ramanand Baral, managing director of Khushi International, a Mumbai-based export house, told IANS. Chillies of various varieties -- soldier, are purchased from places like Kursi Road, Dewa and Malihabad, and then packed afore being sent to Amausi airport for shipment. "The daily pick is of about two tonnes," a market-watcher said. With international, especially European, standards on food quality and safety increasingly becoming stricter, adequate care has been taken to ensure that all parameters, including bio-safety and use of pesticide, are within the prescribed limits.

Lok Sabha passes resolution for peace in Kashmir

New Delhi, The Lok Sabha on Friday unanimously passed a resolution on the situation in Jammu and Kashmir and pledged to work to restore the confidence of the people and the youth in particular.

The resolution, read out by Speaker Sumitra Mahajan, expressed "deepest sense of anguish" on the prolonged turbulence in the

Kashmir Valley and stressed the need to take urgent steps to bring normalcy, but there cannot be any compromise on the integrity and national security", the resolution said.

It appealed to all sections of people in Jammu and Kashmir and also the parts of the country to help restore peace and normalcy in the state. Kashmir Valley is on the boil for the past

five weeks after the killing of rebel commander Burhan Wani. At least 56 people have been killed in clashes between security forces and protesters since July 8.

The valley has been under a security lockdown amid shutdown call by separatist leaders. Educational institutes, shops, businesses and offices have remained closed since the unrest began.

Rajkot, The Gujarat government has finally heeded to the demand of an 18-year-old dalit rape survivor's family that has been demanding that they be declared 'hijrati' (forced migrant). By declaring them 'Hijrati', it will now be the responsibility of the state government to re-settle the family and provide them housing, land and other facilities eligible as per the rules. The 18-year-old girl was dragged out of her house in Vadli village of Rajula taluka by one Hitesh Kathi on December 26 last year and raped. Kathi, who also lives in the same village, and his friend Umesh were arrested after the girl filed a complaint with Rajula police. After the FIR was lodged, on December 31, Raining Dhakhda, a relative of Hitesh allegedly threat-
