Health Ministry details link between air pollution, Covid at House panel meet

NEW DELHI, NOVEMBER 6

IN A presentation to the Parliamentary Standing Committee on Urban Development, which convened a meeting on air pollution on Friday, the Union Health Ministry is learnt to have stated that high air pollution may increase episodes of coughing and sneezing, spreading Covid-19 faster as well as lead to more particle surface for the "virus to stick" and get transported over greater distance. The Ministry has also suggested in its presentation that the virus may potentially survive longer in conditions of high air pollution, it is learnt.

As many as 52 officers from different departments, including urban development, health and environment ministries, as well as representatives from Delhi, Haryana, Punjab, Rajasthan and Uttar Pradesh, were present at the meeting that was attended by 15 parliamentarians from different parties.

While the issue of discussion was air pollution, the presentations as well as question and answers sessions largely revolved around the decreasing air quality and increasing pollution in Delhi-NCR and adjoining areas, it is learnt.

"There were a number of concerns raised including the links between Covid 19 and air pollution, as well as issues like

whether the government has or intends to issue guidelines or protocols for Diwali for which a number of states have already banned the use of firecrackers," said a source.

Stubble burning was also discussed and officials from neighboring states informed the committee of the measures that had been taken to curb it, it is learnt.

The Health Ministry further said there was a direct relation between air pollution and asthma and cardiovascular diseases and 21 of the 30 worst polluted cities in the world were in India, where 12.5 per cent of deaths took place due to air pollution, and that there was an average loss of 1.7 years in life expectancy in the country, it is learnt.

India to help other nations with Covid vaccine supply

INDIA ON Friday conveyed to a host of other nations that it will deploy its vaccine production capabilities to help them battle the Covid-19 crisis.

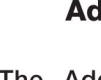

Facebook removes thousands of fake accounts globally

San Francisco. Facebook has removed 1,196 accounts and 994 malicious accounts from Instagram, along with 7,847 Pages and 110 Groups in coordinated inauthentic behaviour.

In October, Facebook removed 14 networks of accounts, Pages and Groups. Eight of them A — from Georgia, Myanmar, Ukraine and Azerbaijan — targeted domestic audiences in their own countries and six networks A — from Iran, Egypt, the US and Mexico A — focused on people outside of their countries.

In Myanmar, it removed 36 Facebook accounts, six Pages, two Groups and one Instagram account linked to Openminded, a PR agency.

"We found this network as part of our proactive investigation into suspected coordinated inauthentic behaviour in the region ahead of the November election in Myanmar," Facebook said in a statement.

The social network also removed 10 Facebook accounts, 8 Pages, 2 Groups and 3 Instagram accounts operated by individuals in Myanmar. They focused on domestic audiences.

In the US, Facebook removed 22 Facebook accounts, 54 Pages and 76 Instagram accounts linked to Rally Forge, a US marketing firm, working on behalf of Turning Point USA and in

New Delhi. Adani Group has unveiled its new name as Bravus Mining and Resources in Australia — after mistakenly believing the word 'bravus' was Latin for 'brave', reports said. Adani has marked its 10-year anniversary of operations in Australia by launching a new brand for its Australian mining business, Bravus Mining & Resources. Bravus Mining & Resources, CEO David Bushoff, said now that construction of the Carmichael Project was well underway, it was the ideal time to give Adani's mining business its own Australian brand. Daily Mail reported that various academics have since pointed out 'Bravus' has a much darker meaning, closely relating to the words 'villainous', 'crooked' and 'deformed'. "We will continue to stand up and deliver for the good of our community, no matter how courageous, it requires us to be, and Bravus, our new name, reflects this intent," Bravus Mining & Resources CEO David Bushoff said on Thursday. Bushoff told the Australian Financial Review the word Bravus meant 'courageous' and during the name change was due to the negativity associated with the term Adani.

CHEMICAL FACTORY BLAST IN PIRANA

Four families accept bodies after assurances on 'better compensation'

EXPRESS NEWS SERVICE AHMEDABAD, NOVEMBER 11

MORE THAN a week after a blast at a chemical factory in Pirana area of Ahmedabad led to the collapse of an adjacent textile godown, trapping and killing 12 workers, the family members of four deceased accepted the bodies Wednesday. The bodies will be cremated Thursday morning.

The family members of four deceased — Nitinbhai Parmar (24), Hitesh Parmar (14) and a couple Mathur Chavda (50) and Angelna (44) — had refused to accept the bodies and sat on a protest outside the post-mortem room of SVP Hospital since November 4 demanding better compensation, free and fair investigation and dignity for the migrant workers' and Dalits' lives.

The families, supported by Independent Vadgam MLA Jignesh Mevani, had planned to march to the Ahmedabad Collector's office Wednesday and submit a representation listing the demands. On Wednesday, following assurances from the authorities the families accepted the bodies.

Apart from an assurance of exploring the viability of increased compensation, the Ahmedabad Police Commissioner's office also issued a written order stating that in light of Deputy Commissioner of Police (zone 6) A M Munia testing positive for Covid-19, the investigation in the matter will be handed over to DCP (zone 7) Prensukh Delu.

The written order, issued by the police commissioner and signed by Deputy Police Commissioner (control room) Dr Harshad Patel, further stated Delu would supervise the investigation until its completion.

12,000 students of municipal schools 'not traceable' in Surat

KAMAAL SAIYED SURAT, NOVEMBER 11

EVEN AS the Gujarat government has announced reopening of schools after Diwali, the Surat Municipal School Board (SMSB), in a survey, has found over 12,000 students studying in Hindi, Marathi and Odiya mediums in its school are "not traceable" and may not have returned from their home states after the lockdown.

The Surat Municipal School Board imparts education in seven mediums — Gujarati, Hindi, Urdu, Marathi, Odiya, Telugu and English — to 1.5 lakh students in 320 schools, from classes 1 to 8. The strength of teaching staff in the schools is 3,900.

Surat city is home to nearly 10 lakh migrants from other states, including Uttar Pradesh, Bihar, Odisha, Maharashtra, Rajasthan, Jharkhand, Uttarakhand, Telangana and Andhra Pradesh, who work in textile, diamond and other industries here. Also, there are over 13 lakh people from different districts of Saurashtra who work mostly in the diamond factories and textile sector in Surat. Most of their children study in municipal schools.

SMSB Education Officer Vimal Desai said, "In a survey, we found that over 12,000 students of Hindi, Marathi and Odiya mediums from classes 1 to 8, were not present for the online classes. Their parents' mobile phones were switched off, so they fall in 'no contact category'."

As per the survey, Desai said, 30,000 students staying in Surat regularly attended online classes, while 35,000 students attended online classes from their native places.

Similarly, around 40,000 students were those who either had no Android mobile phones or had only one Android mobile phone in the house, which would be with the father who went out to work. But they attended the gov-

ement education programmes aired through television channels.

The Board sent teams to the homes of students whose mobile phones were switched off and found them locked. The landlords informed that they had gone back to their native places.

"In homes with just one phone, the education material is sent to the parent as PDF. There are over 35,000 students who do not have television sets or mobile phones... our teachers go to their homes thrice in a week, take class for a group of students and give them home work," Desai said.

Sameera Khan, 14, a class 8 student at Bhestan Municipal School, lives with her grandmother Kubra Pathan after her grandfather died. The grandmother works as a domestic help and supports her education, but uses an ordinary phone. Recently, her grandmother took a loan from her employer



and got Sameera an Android phone. The family migrated from Jalgaon in Maharashtra but she studies in Gujarati medium.

Her younger brothers Amir and Mustafa are in Class 4 and 5 respectively, and stay in the Umarwada tenement with their parents. Their father Abbas drives an autorickshaw for a living and mother Mariyam works as a domestic help.

Sameera, who aspires to be a teacher, told *The Indian Express*, "My grandmother is illiterate and uses an ordinary phone. When online teaching started, I did not have a phone or TV... I started going to the house of my friend

Bushra Shaikh, who has a mobile phone. We do lessons together and also solve the doubts with our teachers. Now I am attending classes with the new phone."

Among her parents, her father has a smartphone phone and her brothers also face the same issue. "They take the help of their friends. Every Sunday, I go home, check their lessons and try to complete them. Their teacher comes home thrice a week and teaches for two hours," she added.

Dipak Parshuram Thakur, 14, a Class 8 Hindi medium student from Palanpur area in Surat, is attending classes from his native place, Sahav village in Jalon district of Uttar Pradesh.

The family left for UP in May, after the textile factory where his father worked, closed. In June, his teacher called his father to say online classes would start and got his phone registered. "My father has an Android mobile phone. Initially I faced some difficulties as the screen was not clear... I would call Satish sir (class teacher) and get my doubts cleared. I would record the lectures and would listen to them again, which helped me," said Dipak. The Thakurs plan to return to Surat after Diwali.

Four Urban Resource Co-ordinators (URC) take care of education related activities in schools, each holding charge of 80 schools. Ramesh Patel, who is a URC, said, "We tried our best but 12,000 students could not be contacted. The migrants are returning to the city and we hope that by February, they will all return, once everything is normal. Once they are back, our teachers will take extra classes to prepare them and conduct examinations."

Apart from maintaining six-foot distance among students with regulated seating plans, staggered time-tables have been suggested to regulate number of students

- Online learning would continue to be the preferred mode of teaching
- Students may attend schools only with the written consent of parents
- No compulsory attendance
- At least six-foot distance to be maintained between students
- Computer hall, laboratory, library can be used to conduct classes
- Temporary space or outdoor spaces may be utilised if weather permits
- Staggering timings for different classes
- Separate lanes for entry and exit
- All gates of schools to remain open, with due markings to avoid crowding
- Announcements through public address system on social distancing
- Flexible attendance, sick leave policies to encourage students and staff to stay at home if unwell
- Awards and incentives for perfect attendance may be discouraged
- Alternate staff for critical school jobs may be given orientation for new job roles
- School campus should be cleaned daily and daily record may be maintained
- Commonly touched surfaces to be frequently cleaned,

- schoolbuses to be sanitised at least twice a day, windows to be kept open without curtains.
- All teaching, learning and sports materials to be disinfected
- Mandatory hand washing of minimum 40 seconds for all students and staff at regular intervals
- Thermometers, disinfectants, soaps, hand sanitisers, masks to be made available in schools
- Health and hygiene lessons to be integrated in every day teaching.

Instructions for parents

- Provide written consent for children to attend school if they wish to send them.
- Ensure that their ward goes to school wearing a mask and sensitise them not to exchange masks with others
- Encourage their ward to wear full-sleeved clothes to minimise interaction with any surface
- Not to send their ward to school if the child is not feeling well.
- Drop and pick children up from school, if possible. If sent by school bus, maintain social distancing
- Clean and sanitise their ward's uniform and other belongings daily

- Ensure that their ward maintains personal hygiene
- Provide two clean napkins daily with their ward for wiping hands
- Give healthy food, fresh fruits and clean water for lunch and advise their ward not to share their tiffin and water bottle with others
- Download the Aarogya Setu App and let their ward commute only when the app shows safe and low-risk status.

Undertaking to be given by parents

- Regular monitoring of child's health
- Keeping the child at home if she is ill or has any specific medical condition that may put them at risk
- Teach and model good hygiene practices at home
- Ensure availability of safe drinking water, clean and safe toilets at home, safe collection, storage and disposal of waste
- Sensitise the ward to cough and sneeze into a tissue or your elbow and avoid touching your face, eyes, mouth, nose
- Ensure emotional safety of the child, prevent stigma and teach children to be considerate of one another
- Offer support to the school to strengthen school safety efforts.

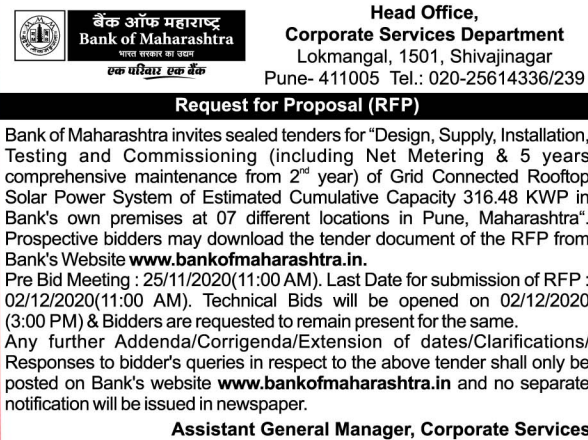
